

IMPORTANT: PLEASE READ TERMS AND CONDITIONS OF PURCHASING A SEASON PASS

- **Season Passes are non-refundable and non-transferable.**
- To be eligible for a pass refund you must purchase the “**REFUND POLICY OPTION**” concurrently with the season pass. There will be no refunds in case of cancellation of operations on account of weather conditions or mechanical failure of equipment.
- All persons must sign and initial a “Release of Liability” agreement prior to obtaining their pass, and without changing or deleting any part of the agreement, which waives certain legal rights, including the right to sue MOUNT TIMOTHY SKI SOCIETY. Parents/guardians are required to sign on behalf of their children under the age of 19 years. All liability waivers must be witnessed.
- All applications are subject to approval by the Board of Directors of the MOUNT TIMOTHY SKI SOCIETY.
- Proof of birth date must be produced, upon request, when seeking aged based discounts.
- Season Passes remain the property of MOUNT TIMOTHY SKI SOCIETY and In the event of misconduct, may be revoked for foul language, misuse of facilities, misuse or violation of the Alpine Responsibility Code. The pass holder may be prohibited use of the lifts for the day without rebate. Use of this pass by anyone other than the registered pass holder, or alterations to the season pass will result in cancellation of that pass. We may request Identification to verify validity of a season pass.
- A valid season pass must be worn at all times when accessing all ski lifts and must be clearly visible to the lift operator. If a Pass holder is not able to produce his/her pass, that individual must purchase a regular lift ticket at regular price.
- A fee of **\$34.82 + HST** will be assessed for the replacement of a lost or stolen season pass.
- Passholders agree not to teach skiing or snowboarding for remuneration on lands controlled by MOUNT TIMOTHY SKI SOCIETY.
- Season passes expire on **April 30th** each year

“Refundable Pass Coverage Option”:

- Refund option is available at 6% of Season Pass price and **must be purchased** at same time as Season Pass purchase. Without the pass coverage, passes are **non refundable** under any circumstances.

Description of Refund coverage:

Coverage provided in the event of

- 1) Injury, sickness or death which prevents the participation of the sport for at least 30 days. Medical conditions that existed prior to the purchase of your season pass are not eligible.
- 2) Transfer by employer that necessitates in transfer of residence outside reasonable accessible radius.

Schedule of coverage: The pro-rated share of the cost of the Season’s Pass for non-participation commencing within:

Refund amounts are based on the following formula:

DATE OF CLAIM	REFUND
Prior to official opening	90%
Before December 31st	75%
Before January 31st	50%
Before Feb.28th	25%
After March 1 st	0%

Refunds relating to family passes will be calculated only on the injured party’s portion of the family pass. The date of non-participation is based on the date the written claim is received in the MT TIMOTHY Administration Office; or date of non-participation where due to sickness or injury (must be supported by a letter from physician) or a job transfer (must be supported by letter from employer). The refund option purchased for your Season Pass is non-refundable.

APPLYING FOR YOUR SEASON PASS:

- ORDER BY PHONE - WE CAN ACCEPT VISA/MASTER CARD PASS PURCHASES OVER THE PHONE
- MAIL IN APPLICATIONS FORMS TO BE POST MARKED BY DEADLINE DATE.
- LIABILITY RELEASE WAIVERS - COMPLETE AT THE MT. WHEN YOU GET YOUR SEASON PASS, OR YOU CAN ENCLOSE WITH YOUR APPLICATION. PARENTS/GUARDIANS MUST SIGN WAIVERS FOR CHILDREN/DEPENDANTS.
- ID SEASON PASSES WILL NOT BE PROCESSED UNTIL A SIGNED RELEASE OF LIABILITY FORM IS COMPLETED. WE CANNOT ACCEPT "FAXED" OR "EMAILED" LIABILITY WAIVERS - ORIGINALS MUST BE SIGNED, WITNESSED IN ORDER FOR US TO PROVIDE YOUR PASS. PROCESSING AVAILABLE PRIOR TO SKI AREA OPENING AT SKI SWAP IN NOVEMBER.
- YOUR PASS CATEGORY IS DETERMINED BY YOUR AGE ON THE DAY OF PURCHASE. PROOF OF BIRTH DATE MUST BE PROVIDED UPON REQUEST WHEN SEEKING AGE-BASED DISCOUNTS.

FAMILY DISCOUNT:

- **Minimum of 3 family** applicants to qualify for the special "Family Discount".
- We offer discounted pass rates to families: defined as one or both parents/guardians and their children up to age 18 years living at home.
- *Families of six or more members only pay for the first 5 family members and the remaining family members only pay a **\$34.82 plus HST** pass processing fee.
- **Maximum of 2 Adults** on a Family Pass application. Adult children 19 and up are excluded from the family rate discount. They must apply separately.
- Foster children & foreign exchange students 18 and under can be included on the family pass, providing you supply a letter of proof from the sponsoring organization.

 All pass applications are subject to review and approval by the Board of Directors of **MT TIMOTHY SKI SOCIETY**.

STUDENT SEASON PASS:

- **Adult students ages 19-24 attending recognized post secondary education, full-time can apply for a Student Season Pass.
- Proof of registration and a copy of a receipt of payment from recognized post secondary institution is required.
- Adult students 19-24 are excluded from family pass

SEASON PASS PICK-UP:

Season pass pictures, processing and pick up available at Guest Services on the mountain when the ski area opens in December for the season. Prior to official opening: Season Pass pictures & processing are available at the Ski Swap in Williams Lake first weekend in November. Receipts for passes sold will be issued by the office after September and can be used for proof of pass prior to season.
